Mayor Turner called the meeting to order at 7:00 p.m.

### **Roll Call:**

Roll call was answered by Councilman Blankenship, Councilman Dinn, Councilman Herald, Councilman Martin and Councilwoman Wilson.

### **Approval of Minutes:**

**Upon motion of Councilman Blankenship, seconded by, Councilman Herald to approve the Minutes of April 4, 2011, Regular Meeting. Mayor Turner called for a vote. Motion carried unanimously.**
