The regular meeting of the Wilder City Council was held on Monday, July 18, 2011 at the Wilder City Building, 520 Licking Pike, Wilder, Kentucky 41071.

Call to Order:

Mayor Turner called the meeting to order at 7:00 p.m.

Roll Call:

Roll call was answered by Councilman Blankenship, Councilman Dinn, Councilwoman Gearding, Councilman Herald and Councilman Martin.

Approval of Minutes:

Upon motion of Councilman Blankenship, seconded by, Councilman Dinn to approve the Minutes of June 20, 2011, Regular Meeting and June 27, 2011 Special Meeting. Mayor Turner called for a vote. Motion carried unanimously.

Mr. Vance informed council of the proposed changes.

Discussion ensued regarding the speed limits and parking restrictions.

Upon motion of Councilman Blankenship, seconded by, Councilman Dinn to approve Ordinance No. 11-0701: An Ordinance Amending Chapter 72 Section 72.02 of the Wilder Municipal Code setting speed limits and establishing parking restrictions and stop sign locations for certain city maintained streets located in the City of Wilder. Mayor Turner called for a vote. Motion carried.

Citizen's Comments:

Mr. Kevin Gordon, resident of Signal Hill, thanked Councilman Martin, Mr. Vance and Mr. Verax for meeting him at Signal Hill during a storm to view the drainage issue regarding 33 Guardian Drive.

Mr. Gordon advised that the Sanitation District No. 1 came and reviewed the issue and stated that there is nothing that they need to do or change on the property for the water flow. All grading looks to be the same as originally done and doesn't appear to be changed in any way.

Mr. Gordon expressed that the Signal Hill Board has still decided to research the issue further and possibly do some work on the property to help not create any issues to its neighbors. The board is still meeting and working with a contractor and working out costs for some possible potential work and it will then be voted on by the homeowners.

Mr. Gordon asked Councilman Dinn who notified him of the drainage problem at 33 Guardian Drive.

Councilman Dinn advised that Mrs. Stephanie Antony contacted him the day the before the June 20, 2011 council meeting.

Mr. Gordon asked what the procedure was for handling citizens concerns.

Mr. Verst stated that Council Members or Mayor would try to help out if they can to help get something resolved. If it goes further than that then this particular situation is between the private property owners and the city would not get involved.

Discussion ensued regarding how these issues are handled.

Mayor's Comments:

Mayor Turner announced that the Maintenance Department has finished the dredging at Frederick's Landing.

Mayor Turner informed council that there will be a Mayor's Meeting on July 26, 2001 at 7:30 a.m. if any of them would like to attend.

City Administrator Comments:

Mr. Vance informed council that he has the plans for the street repairs to be done on Wesley Drive if they would like to review them.

Council Comments:

Councilwoman Gearding – Stated that she has had several residents contact her regarding the property located at 1018 Johns Hill Road, questioning when the graveled area would be paved.

Mr. Vance advised that he has spoken with Mr. Marschman regarding this issue and he informed him that he will be building a garage and would like to pave the area after the garage is completed.

Councilwoman Gearding expressed that there are still problems with speeding and would like to revisit the option of speed bumps. She would like the whole city to be looked at while considering this.

Mr. Vance and Chief Rouse are checking into the cost of them and will get back to council with the information.

Councilman Martin – Questioned if salt has been loaded into the new salt house.

Mr. Vance stated that they have put in all the salt necessary and still have plenty of room. Mr. Vance also advised that the Maintenance Department is completely moved into their new facility and the property sale of the old one is complete.

Councilman Blankenship – Commended the fire department on the letter they received from the City of Cold Spring on the paramedics help.

Councilman Dinn – No comment.

Councilman Herald – Stated that he would like for council to take their annual bus ride tour of the city. Councilman Herald will set this up for a future date.
