#### June 3, 2013

The regular meeting of the Wilder City Council was held on Monday, June 3, 2013 at the Wilder City Building, 520 Licking Pike, Wilder, Kentucky 41071.

#### Call to Order:

Mayor Turner called the meeting to order at 7:00 p.m.

#### Roll Call:

Roll call was answered by Councilman Robert Blankenship, Councilman Brack Herald, Councilwoman Monica Gearding, Councilman Robert Arnold, Councilman Robert Honaker and Councilman Bradley Jones.

#### **Approval of Minutes:**

Upon motion of Councilman Blankenship seconded by Councilman Herald to approve the Minutes of May 6, 2013 Regular Meeting. Mayor Turner called for a vote. Motion carried unanimously.

#### **Attorney's Report:**
