#### Call to Order:

Mayor Turner called the meeting to order at 7:00 p.m.

#### Roll Call:

Roll call was answered by Councilman Arnold, Councilman Robert Blankenship, Councilman Tim Gilkison, Councilman Robert Honaker, Councilwoman Valerie Jones and Councilman Jerry Sebastian.

## **Approval of Minutes:**

Upon motion of Councilman Blankenship seconded by Councilman Sebastian to approve the Minutes of May 1, 2017 Regular Meeting. Mayor Turner called for a vote. Motion carried unanimously.

General Fund ending 04/30/17

Upon motion of Councilman Arnold seconded by Councilman Blankenship to Approve financial reports and authorize payment of bills for General Fund Ending 04/30/17. Mayor Turner called for a vote. Motion carried unanimously.

### Attorney's Report:

Attorney Verst presented Resolution No. 17-0501: A Resolution Authorizing the Mayor to Make Application to the Commonwealth of Kentucky Department of Transportation for 4 Parcels of Surplus Right of Way along Kentucky S.R. 9 at Banklick Road in the City of Wilder, Campbell County Kentucky.

Mr. Vance gave a description of the property locations and the purpose/process for obtaining the property for two adjoining businesses (Wilder Self Storage and Carlisle). The city will simply act as a conduit to obtain the property and will be refunded by the businesses any and all fees therefore leaving the city with no expense.

#### **Council Comments:**

#### Councilman Arnold:

- Commended Officer Chris Vance who helped a disabled motorist.
