The regular meeting of the Wilder City Council was held on Monday, June 7, 2010 at the Wilder City Building, 520 Licking Pike, Wilder, Kentucky 41071.

Attorney Verst stated in absence of the Mayor a Mayor Pro-Tem needed to be appointed.

Upon the motion of Councilman Martin, seconded by Councilman Herald, to appoint Councilman Blankenship as Mayor Pro-Tem. Mayor Pro-Tem Blankenship called for a vote. Motion carried unanimously.

Mayor Pro-Tem Blankenship called the meeting to order at 7:00 p.m.

Upon motion of Councilman Martin, seconded by, Councilman Dinn to Approve financial reports and authorize payment of bills for General Fund Ending 04/30/10 and Fredericks Landing ending 04/30/10.

Mayor Pro-Tem Blankenship called for a vote. Motion carried unanimously.

Attorney's Report:

Attorney Verst presented Ordinance No. 10-0601: An Ordinance adopting The City of Wilder, Kentucky's Annual Budget for the Fiscal Year 07/01/10 through 06/30/11 by estimating Revenues and Appropriating Funds for the operation of City Government.

Councilman Martin questioned about how many would be taking the raise verses the lump sum amount.

Mr. Vance replied that the majority of the city's employees would be taking the percentage raise. Only about three would take the lump sum.

Councilman Dinn questioned if this was an across the board percentage raise and where the funds for this coming from.

Mr. Vance replied that several options were taken into consideration, the raise would end up being about a fifty cent per hour raise giving the employees about twenty dollars a week. The funds for this raise were taken out of two line items sewer and property.

Councilman Dinn questioned the additional fees for city engineer.

Mr. Vance responded that the city engineer receives an additional 12% of the cost of a project.

Upon the motion of Councilman Dinn, seconded by, Councilman Martin to approve Ordinance No. 10-0601 for the Revenues and Appropriating Funds for the operation of the city. Mayor Pro-Tem Blankenship called for a vote. Motion carried unanimously.

Councilman Herald questioned if the property at 404 Licking Pike had received an appraisal after it had been purchased.

Mr. Vance replied that they didn't have the house appraised; but that the property assessment value was \$86,000.00 and we purchased the house for \$62,000.00.

Mr. Vance discussed street repair bids for this year. Concluded that out of the street proposals Jarco was the lowest bidder at \$184,859.50

Upon the motion of Councilman Herald, seconded by Councilman Dinn to award the contract for street repairs on Wesley, Brigade, Brigadier, Overview, Sentinal, (from Major Court to Johns Hill) for \$184,859.50, to Jarco. Mayor Pro-Tem Blankenship called for a vote. Motion carried unanimously.
