



NO BURNING between 6 a.m. and 6 p.m.


October 1 to December 15 and February 15 to April 30



Higher temperatures during the day will dry out the fuels (leaves, twigs, and branches) that feed wildfires.



Wind speed picks up during the day and can spread the flames faster.



Fuels lose moisture when the humidity drops during the day.




OKAY TO BURN

OK TO BURN between 6 p.m. and 6 a.m.

October 1 to December 15 and February 15 to April 30



Temperatures drop at night and fuels won't dry out as fast.



Wind speed drops and is less likely to reignite embers or spread sparks.



Humidity levels rise at night and fuels absorb the moisture.




FIRESEASON



Kentucky's fire seasons are Oct. 1 to Dec. 15 and Feb. 15 to April 30.

During the fire hazard seasons it shall be unlawful for any person to set fire to, or to procure another to set fire to, any flammable material capable of spreading fire, located in or within 150 feet of any woodland or brushland, except between the hours of 6:00 p.m. and 6:00 a.m., or when the ground is covered with snow, KRS 149,400.



This statute is intended to prevent forest fires by allowing outdoor burning only after 6 p.m. when conditions are less likely to cause a wildfire to spread.







Don't let your burn pile start a wildfire!



Clear vegetation for 10 feet around your burn pile. Keep your fire small and controllable.



Be prepared just in case. Have a source of water (hose or bucket) and a shovel nearby.



Stay with your fire until it is dead out, even at night. Never leave your fire unattended.

If your burn pile starts a wildfire, you may have to pay for the cost of putting it out.

PUBLIC WORKS DEPARTMENT POT HOLES ROAD MAINTENANCE

Do you ever wonder who is responsible for street/road maintenance and pot hole repair. Depending on what road it is determines what agency (city or state) will make the repairs. In the City of Wilder many of the heavily travelled roads are maintained by the Kentucky State Transportation Cabinet. Below is a list of roads that fall under state maintenance.

- Johns Hill Road State Route 2345
- Three Mile Road State Route 2238
- Moock Road State Route 1632
- Licking Pike State Route 9
- AA Highway State Route 9
- I-275 Including on and off ramps

If you encounter any problems, pot holes, slippage, signage, drainage problems or traffic signal issues, on any of the routes listed above, please report these issues directly to the Kentucky Transportation Cabinet District Six Offices. The number is listed below:

BARKING DOGS

Just a reminder the City of Wilder has ordinances pertaining to animals specifically with regard to the following issues:

A Leash Law, meaning dogs are not permitted to run at large. They must be on a leash if they are off of the property where they are normally kept.

Habitual barking. No person shall harbor, keep, or permit a dog owned by him or which is under his control, which by loud and frequent or habitual barking, howling or helping, caused annoyance or disturbance to other person or persons living or having a right to be in the vicinity.

Removal of excrement. Please be responsible and clean up after your pet. The city has installed more waste stations along sidewalks and parks in the city.

ENVIRONMENTAL ASSESSMENT LAND WATER CONSERVATION FUND \$250,000 GRANT FREDERICKS LANDING AMPHITHEATER

The City of Wilder has been selected to receive a \$250,000 Land Water Conservation Fund (LWCF) grant from the Federal Government through the National Park Service (NPS) and the Kentucky Department for Local Government (DLG).

One of the conditions of the grant is for the city to prepare an Environmental Assessment (EA) of the project. States are required to ensure the interested and affected public has had an opportunity to review and provide written comments on completed environmental assessments for LWCF proposals. This public comment period shall be no less than 30 days. The notice an EA is available for review shall be published in the local newspapers and community notices, posted on the sponsoring agency's web site, and made broadly known to the public in such a way that the interested and affected public has ample notice of the public comment period. The State/project sponsor is responsible for reviewing the public comments. These comments and the responses that address all substantive comments are to be included in the proposal's submission to NPS.

The Environmental Assessment has been prepared and is available for review on the city's web page at https://wilderky.gov/. The public comment period will run from February 21, 2020 through March 23 2020.

PARK IMPROVEMENTS

I am very excited to announce that the City of Wilder has received a \$250,000 Land and Water Conservation Grant administered by the Kentucky Department of Local Government. Generally, such grants provide "federal funds to protect important natural areas, acquire land for outdoor



recreation and to develop or renovate public outdoor recreation facilities." Our application was to use the grant to start the revitalization of Fredricks Landing, "the Crown Jewel" of the City, and specifically to build an amphitheater at the Landing. The award was presented to me, on behalf of the City, by new elected Governor Andy Beshear on February 3, 2020. At the presentation, I thanked the Governor and mentioned that this not only will improve Fredricks Landing but will be another catalyst for economic development in the City Center. I also invited him back once completed to show the value of making investments in local communities. On a related note, stay tuned for an exciting announcement about a community event that is being planned at Fredricks Landing for later this summer.

ROAD UPDATE

The good news about Johns Hill road is that the Kentucky Department of Transportation has completed re-enforcing the road. While it took some time for them to complete the project, I am hopeful that the area will now be stabilized. We did get word that the maintenance crews will be back in the spring to resurface the area. For those who travel that road on a regular basis, thank you for your patience. We have also received word from the Dept of Transportation that there is money in the next state budget to study the best way to fix the interchange at Route 9 and I275. While I was hoping they would adopt our suggestions for a short-term fix, I am happy to report that it is the highest priority of all road projects identified in Campbell County.

UPCOMING EVENTS / UPDATES

Please plan to attend the Easter Egg Hunt in April. See the details of that included in this newsletter and note that we will be holding the event this year at Fredricks Landing due to the construction of the new fire station. Happy Easter to all.



Related to the fire station, please know that even with all the rain this winter, we are close to being on schedule and well within the planned budget. The completion date and opening is scheduled for September. Also, with the completion dates in sight, there is some interest and excitement around the new uses for the old fire stations. I will keep you apprised of any new develops.
