Mayor Robert Arnold called the meeting to order at 7:00 p.m.

Approval of Minutes:

Upon motion of Councilman Blankenship, seconded by Councilwoman Decker to approve the minutes of October 5, 2020 Regular Meeting. Mayor Arnold called for a vote. Motion carried.
