The regular meeting of the Wilder City Council was held on Monday, December 6, 2021 at the Wilder City Building, 520 Licking Pike, Wilder, Kentucky 41071.

Call to Order:

Mayor Robert Arnold called the meeting to order at 7:00 p.m.

Roll Call:

Roll call was answered by Councilman Andrew Williams, Councilman Jim Profitt, Councilwoman Valerie Jones, Councilwoman Sandy Decker, and Councilman Robert Blankenship.

Approval of Minutes:

Upon motion of Councilman Profitt, seconded by Councilwoman Decker to approve the minutes of November 15, 2021 Regular Meeting. Mayor Arnold called for a vote. Motion carried.

 Norris on the camper ordinance that needs to be revised.

Attorney Verst presented Ordinance No. 21-1101: An Ordinance amending the City of Wilder, Kentucky's annual budget for fiscal year 07/01/2021 through 06/30/2022 by estimating revenues and appropriating for the operation of city government. (Second Reading)

Upon motion of Councilwoman Jones, seconded by Councilman Williams to approve Ordinance No. 21-1101: An Ordinance amending the City of Wilder, Kentucky's annual budget for fiscal year 07/01/2021 through 06/30/2022 by estimating revenues and appropriating for the operation of city government. Mayor Arnold called for a vote. Motion carried. (Second Reading)

Mayor Arnold informed council that the buyer for the North Fire Station needs a couple extra weeks to close on the building. They would like to have an extension until December 17, 2021.

Upon motion of Councilman Profitt, seconded by Councilwoman Decker to approve a second addendum to the sale agreement of the North Fire Station to extend the closing date to December 17, 2021 and to authorize Mayor Arnold to sign the contract. Mayor Arnold called for a vote. Motion carried.

City Administrator's Report:

- City Administrator Vance gave an update to council on several things happening in Wilder in regards to Economic Development. City Administrator Vance met with an investor from Broadus Capital Investments. They are interested in Frederick's Landing North Property. He handed out some information to council. More information to come.
- City Administrator Vance sent council an email regarding a meeting at Campbell County Fiscal Court on Wednesday from 5:30 to 7:30. The Licking River Greenway people hired Copperhead Environmental Consulting Firm to determine whether or not they can use the Licking River as a recreational area. More information to come.
- The Rumpke Property sold to Neyer Company. The Economic Development Committee will be meeting with City Administrator Vance in the near future to discuss this property.
