

GOALS

SENSIBLE GROWTH

- Grow smart, not fast keep taxes reasonable for the entire community.
- Protect the small town charm yet grow responsibly.
- Post an annual report for better transparency on the health of our economy & city.
- Develop a Shop Local Program to drive traffic to Wilder's businesses.

SAFE & PEACEFUL

- Create a capital replacement schedule to ensure all departments have the equipment they need to protect & serve the community.
- Replace the aging, 26 year old fire engine.
- Always provide high levels of service for our public's safety, security and infrastructure needs.
- Consider hosting police/fire seminars to educate the community on the newest threats, i.e. cyber security;
 CPR classes (fee based).

GOALS

ECONOMIC RESILIENCY

- New ventures must add jobs, increase Wilder's tax base through gross receipts & payroll taxes.
- Establish a well-defined application
 & qualification process for incentives.
- Partner with adjacent cities on development of Licking River banks & Frederick's Landing.
- Evaluate "pay as you charge" stations for electric vehicles.

FISCALLY CONSERVATIVE

- Plan & conduct low cost events for all which might include fitness classes, annual Medicare Seminar, family event, w/Petting Zoo, Hearing Health Seminar, with free hearing test. Attract people to the city.
- Every capital intensive project will have a cost benefit analysis.
- Sand court is creating costly issues at the park. Remove the sand - add pickle ball courts since demand is high.
- Responsible management of revenues & expenditures Balanced budget.
- Retain essential workers turnover is costly

ACCOMPLISHMENTS

- Balance budget prepared & adopted
- Annual report created & published
- ► First Friday-Shop Local monthly program launched 7 businesses participating with an incentive. Goal to condition the community to support Wilder's businesses.
- Capital replacement schedule created
- Quint Fire Engine ordered to replace the 26 year old pumper.
- ► CPR classes conducted at businesses & for residents.
- AI / Cyber Security Seminar scheduled, Sept. 2023.
- Improved, open communications with residents on matters important to them, i.e. Barleycorn's parking lot expansion, Fischer development & history; 3 Mile Road closures, SD1-Water projects.
- On-going collaboration with state officials

ACCOMPLISHMENTS CONTINUED

- Worked with the county to position Wilder to win the Castellini Home Fresh opportunity adding approx. 180 new jobs
- ► Educational seminars, family events, fitness/health & well-being classes & kids programs offered
- Two new, permanent pickle ball courts under construction
- As evident in final P&L results to follow, clear fiscal management of revenue & expenses
- Transparent communications
- Suggestion box in lobby
- ► New snow plow budgeted 2023-2024
- Ethics Board Re-established

ACCOMPLISHMENTS CONTINUED

- Retentions agreement in place for Police AND Fire parity for first responders.
- Merit pay program designed & implemented for the entire staff
- Secured consulting agreement with the Kentucky League of Cities to update the city's outdated personnel policy & align the policy with more current practices & benefits
- Road repairs identified & will be addressed 2023-2024 fiscal year.
- Met with Southbank Partners CEO & board member to evaluate mutual benefits in a partnership. How to best connect Wilder with adjoining cities via bike & walking trails, for example.
- More effective use of videoed Public Service Announcements (PSA)







SAFETY & SECURITY - FIRE - FY 2022

NEW EQUIPMENT

- > QUINT (ladder engine-see photo) ordered \$1.2M
- > Fire Simulator Prop
- > Replaced 800' of fire hose
- ➤ Three sets of Personal Protective Equipment (coats, pants, gloves, hoods, boots)
- Positive Pressure Fan (battery powered) used to remove contaminated air from a structure)

TRAINING

- ➤ Department personnel received 5,399 hours of Fire/EMS training
 - ➤ Full-time 1358, part-time 3310, volunteer 731
- ➤ Hosted 7 CPR classes for citizens & businesses with over 70 certifications
- Presented fire extinguisher training to Wilder businesses

- > Fish Fry's served over 2000 meals to the community
- ➤ Wilder Touch-a-Truck event
- ➤ Senior Picnic (10/22) prepared food & offered blood pressure checks

EMERGENCY RESPONSES

- Splash Pad opened Memorial Day weekend; closes Labor Day weekend.

PUBLIC WORKS - 2022-2023

REGULAR MAINTENANCE ITEMS

- ➤ Maintain/check/clean Splash Pad, maintain grass on all city properties, clean city building
- Remove trash from city right of ways, check/repair/monitor boat dock at Fredericks Landing.
- Replace HVAC filters quarterly, maintain city dog waste boxes
- ➤ Maintain equipment & vehicles
- Community Hall Set up for rentals, clean after events

STREETS

- Repair/replace street signs, i.e. no parking, speed limits, etc.
- Repair potholes & small curb projects
- Snow removal & salting of city streets

PUBLIC WORKS - CONTINUED

SPECIAL PROJECTS

- Updated landscaping around the city building.
- Cleared brush along Gloria Torrell for new development.
- Community garden pick up compost & monitor water barrels; fill as needed.

ASSIST OTHER AGENCIES / DEPARTMENTS

- ➤ Participate in Campbell County Spring & Fall clean-up events at Fredericks Landing.
- > Switch out damaged waste / recycle carts for residents; work with Rumpke to maintain supply.
- Assist Fire Department with Fish Fry & Turkey Raffle events.

Banners & Signs – put up & remove banners / signs for special events.

PUBLIC WORKS

CITY PARKS

- > Painted the shelters & replaced bathroom fixtures at Fredericks Landing.
- ➤ Painted & stained the picnic tables at Fredericks Landing & the city center park.
- New mulch at Fredericks Landing

TRAINING

> Aaron Keene trained new hire, Andrew Maus, in public work's operations.

2023 STREET REPAIR

- ➤ This year we will be doing spot repairs on several streets throughout the city. The following streets will be addressed this year:
 - Portions of Colonel Point in cul de sac and around catch basin
 - Portions of Guardian Drive around catch basins
 - Portions of Plum Street by Castellini
 - Areas on St. Johns Lane
 - Intersection of Town Drive and Gloria Terrell at Thornton's
 - End of Banklick Road Phase II to end of street
 - Area repairs on South Street and Andrews Way in conjunction with repairs by water and sewer contractor
 - Possibly an area at the intersection of Aspen Pines Drive and Aspen Court. Intersection needs milled and repaved.
- In addition to these area repairs, we will be putting a crack sealing project out to bid for late fall or early spring.
