

- Partner with adjacent cities on development of Licking River banks & Frederick's Landing.
- Evaluate "pay as you charge" stations for electric vehicles.

### FISCALLY CONSERVATIVE

- Plan & conduct low cost events for all which might include fitness classes, annual Medicare Seminars, Children and family events. Attract people to the city.
- Use a CBA (Cost and Benefits Analysis) for capital intensive projects; where logical to do so.
- Responsible management of revenues & expenditures Balanced budget.
- Retain essential workers turnover is costly

## **ACCOMPLISHMENTS**

- Request for Economic Development assistance will be reviewed on case by case basis using the criteria adopted by surrounding jurisdictions.
- ▶ Balance budget prepared & adopted for FY24/25
- ▶ 1st annual report created & published August 2023.
- First Friday-Shop Local monthly program continues 7 businesses participating with an incentive. Goal to condition the community to support Wilder's businesses.
- ► CPR classes conducted at businesses & for residents.
- Improved, open communications with residents on matters important to them, i.e. Barleycorn's parking lot expansion, Fischer development & history; 3 Mile Road closures, SD1-Water projects, Neyer, and Road Repairs.
- On-going collaboration with state and county officials.
- Police recruit strategy to build our bench hired 2 new recruits, first since 2000's.
- Increasing FF/EMT and Paramedic manpower.
- Leveraging a relationship with National Radio host to promote and advertise our businesses.

## ACCOMPLISHMENTS CONTINUED

- ► Educational seminars, family events, fitness/health & well-being classes, Municipals & kids programs offered.
- Two new, permanent pickle ball courts constructed and opened in September 2023.
- As evident in final P&L results to follow, solid revenue forecasting, clear fiscal management of expenses, sizeable surplus expected.
- Transparent communications through PSA, Facebook and letters to the community. Promote events and public safety.
- ► New snow plow purchased and placed in service Winter 2023
- Ethics Board has been transitioned to Northern Kentucky Regional Ethics Board.
- Business meetings Visiting businesses throughout the year.

# ACCOMPLISHMENTS CONTINUED

- Retentions agreement in place for Police, Fire and Public Works.
- Community Gardens located near Frederick's Landing.
- ▶ Merit pay program designed & implemented for the entire staff Year 2.
- Kentucky League of Cities updated the city's outdated personnel policy & aligned the policy with more current practices & benefits effective January 2024.
- Road repairs completed.
- ► Evaluating the proposal with Southbank Partners for mutual benefits for the city. How to best connect Wilder with adjoining cities via bike & walking trails, for example.
- As promised, the city is receiving 100% of the tax revenue from the Fischer Development.
- New waste removal service transitioned to BestWay.







- > Fire Simulator Prop
- > Replaced 800' of fire hose
- > Three sets of Personal Protective Equipment (coats, pants, gloves, hoods, boots)
- Positive Pressure Fan (battery powered) used to remove contaminated air from a structure)

### **TRAINING**


- > Department personnel received 4,368 hours of Fire/EMS training
- ➤ Hosted 6 CPR classes for businesses in Wilder; 97 employees
- Presented fire extinguisher training to Wilder businesses
- Lieutenant Ryan Boothe became certified as a Rope Rescue Technician.
- ➤ Captain Jeff Lang and Lieutenant Casey Krentz became certified in Active Shooter Hostile Environment Response. (ASHER)

# SAFETY & SECURITY - FIRE CONTINUED

- > Applied for a SAFER Grant, if received could hire 3 additional FF/Paramedics

- Fish Fry's served over 2000 meals to the community
- ➤ Wilder Touch-a-Truck event
- > Turkey Raffle event
- ▶ Breakfast with Santa event 500+ adults and children attended.

### **EMERGENCY RESPONSES**

- > 91 Fire / EMS responses to neighboring department areas
- ➤ 957 total Wilder responses
  - > 754 EMS responses
  - > 203 Fire incidents

- Remove trash from city right of ways, check/repair/monitor boat dock at Fredericks Landing.
- Replace HVAC filters quarterly, maintain city dog waste boxes
- ➤ Maintain equipment & vehicles
- Community Hall Set up for rentals, clean after events

### **STREETS**

- Repair/replace street signs, i.e. no parking, speed limits, etc.
- Repair potholes & small curb projects
- Snow removal & salting of city streets

# PUBLIC WORKS - CONTINUED

### **SPECIAL PROJECTS**

- Updated landscaping around the city building.
- Completed painting road way stop bar and all wood benches in the city.
- Cleared brush from AA Highway around Rosewood Drive.
- Community garden pick up compost & monitor water barrels; fill as needed.

### **ASSIST OTHER AGENCIES / DEPARTMENTS**

- Participate in Campbell County Spring & Fall clean-up events at Fredericks Landing.
- Switch out damaged waste / recycle carts for residents; work with Bestway to maintain supply.
- Assist Fire Department with Fish Fry & Turkey Raffle events.

Banners & Signs – put up & remove banners / signs for special events.

## PUBLIC WORKS

### **CITY PARKS**

- Painted the shelters & replaced bathroom fixtures at Fredericks Landing.
- ➤ Painted & stained the picnic tables at Fredericks Landing & the city center park.
- New mulch at Fredericks Landing.
- Revamp the landing entrance sign.

### **TRAINING**

- ➤ Hired two seasonal Part-time employees. Looking to hire additional full time Public Works Laborer.
- Andrew Maus finished two classes. Andrew should complete his road scholar next year and then start on his road masters program.

### WHAT'S TO COME

### 2024 STREET REPAIR

- This year we will be doing spot repairs on several streets throughout the city. The following streets will be addressed this year:
  - Portions of Colonel Point in cul de sac and around catch basin -Completed
  - Portions of Guardian Drive around catch basins Completed
  - Portions of Plum Street by Castellini Completed
  - Areas on St. Johns Lane Completed
  - Intersection of Town Drive and Gloria Terrell at Thornton's -Completed
  - End of Banklick Road Phase II to end of street Summer 2024
  - Area repairs on South Street and Andrews Way in conjunction with repairs by water and sewer contractor - Completed
  - Possibly an area at the intersection of Aspen Pines Drive and Aspen Court. Completed
- In addition to these area repairs, we will be putting a crack sealing project out to bid for late fall or early spring.
