No person shall harbor, keep, or permit a dog owned by him or which is under his control, which by loud and frequent or habitual barking, howling or yelping, causes annoyance or disturbance to other person or persons living or having the right to be in the vicinity so as to hear said barking, howling or yelping.

# TANK +

Tank Plus is an on-demand, flexible transportation service that provides curb-to-curb rides within the designated zone. It also connects you to fixed-route services for travel beyond the zone.

Instead of fixed bus routes, Tank Plus uses smaller vehicles that you can schedule as needed, either through the TANK+ app or by contacting their call center. The image below is what the pickup bus looks like.

Service is available Monday-Sunday from 9AM to 5PM (Including Holidays).

As a pilot program, not all areas of Wilder are currently included in the curb-to-curb pickup zone. However, we encourage residents outside the zone to still reach out and inform them, as the zones will expand to include more areas for curb-to-curb pickup as the demand goes up.

#### FAQ

Traveling curb-to-curb within the zone is \$5.00 per trip


Traveling from your zone to a designated fixed route transfer point is \$2.50 per trip (Full bus fare will apply for fixed route trips)







#### FROM THE DESK OF THE CITY ADMINISTRATOR:

#### PLANNING AND ZONING INSIGHTS PART TWO

Not all cities in Kentucky have planning and zoning regulations. If a city desires to adopt planning and zoning regulations, it must abide by Kentucky Revised Statute Chapter 100 (KRS 100). The last article discussed the makeup and type of planning and zoning commissions. This article will discuss some of the requirements that must be undertaken for a jurisdiction to adopt planning and zoning laws.

After a city or county decides it desires to adopt zoning and establishes the type of planning unit it will operate under, the next steps are outlined as follows:

COMPREHENSIVE PLAN REQUIRED: Each planning unit must prepare a comprehensive plan. The plan shall serve as a guide for public and private actions and decisions to assure the most appropriate methods to develop public and private property. Elements of the plan include at a minimum:

- A statement of goals and objectives
- A land use plan
- A transportation plan
- A community facilities plan
- Provisions for military installations
- Additional items may include elements such as community renewal, housing, flood control,
- pollution, conservation, natural resources, regional impact, historic preservation and other programs the planning commission may desire

In adopting a comprehensive plan the jurisdiction shall base the plan on research on population present and forecasted, economic survey and analysis, existing land and building use, transportation and community facilities as well as any other research that will further serve the purpose of the comprehensive plan.

The statement of goals and objectives must be approved by the planning commission and then also approved by the legislative body of the jurisdiction. The adoption of the goals and objectives is a public process involving one or more public hearings. Notice of adoption is required to be sent to all adjoining planning units, including independent, joint or regional.

Adoption of the comprehensive plan or individual elements of the plan are required to be completed at a public hearing. It may be done all at one time or each individual element. After adoption, the jurisdiction is required at least once every five (5) years to review, amend or readopt the plan elements. This also requires a public hearing.

Public input into the process of adopting such a significant set of regulations is very important. The more input and research received prior to adoption, the better the plan and outcome will be for the community.

The City of Wilder last completed the comprehensive plan update in 2019. A copy of the plan is on the city's website at Comprehensive Plan | Wilder, KY (wilderky.gov). It has been five (5) years since the adoption so it is time to once again begin the process of reviewing and/or amending as necessary the city's plan. We will be putting out information and public hearing notices to begin the process.

#### FROM THE DESK OF THE MAYOR:

Dear Wilder Residents,

As this is an election year for council members, we have decided to hand-deliver this edition to ensure you get to know those running to serve you. I am thrilled that for the first time in years, we have more candidates on the ballot wanting to join this administration and to serve Wilder than seats available. More candidates gives the public more choices.

This delivery maximizes viewership, therefore it is also the perfect opportunity to update you on some additional accomplishments since the last delivered publication. Keeping you informed is paramount to a healthy and trusted relationship with the city. It is our goal to deliver the updates twice a year.

#### POLICE / FIRE / PUBLIC WORKS-INFRASTRUCTURE / STAFF

- Designed and implemented a Retention Agreement for public works staff. All essential workers are part of the city's focus on critical skill retention based on measurable objectives.
- Two police recruits were hired and the first to attend the academy in over 20 years. The city could not continue to rely on a plan to hire retired officers. We needed a bench; we needed a recruiting strategy.
- Road repairs completed. Seven streets have been repaired. We will be focused on crack sealing late fall, 2024, or early spring, 2025.
- Hired and continue to hire new firefighters EMTs paramedics. This is the succession plan to cover attrition and the needed manpower in anticipation of the new residential developments.
- Upgraded, painted and revamped much of Frederick's Landing. Hire 2-seasonal part-time employees to supplement the full-time staff and make significant progress on the parks and landscaping.
- Upgraded a 16 year old staff vehicle which was a heavy maintenance burden, lacked reverse transmission, was not reliable and was creating a serious safety issue for our City Administrator who is also the Building Inspector.
- Implemented Year 2 of the Merit Program designed in 2023 to award our employees for going above and beyond as determined by Department leaders.
- Continued to fund, through effective cost management, new and existing benefits and increase compensation for the entire staff who remain Wilder's greatest assets.

#### BUDGET / EXPENSE MANAGEMENT / TAX BASE / ECONOMIC DEVELOPMENT

- The second annual report published providing greater transparency to the city operations, the revenues & expenses and accomplishments. Found on the city website.
- The city's revenue base is growing based on an increase in payroll taxes from the Castellini Home Fresh expansion & their selection of Wilder for the operation. Revenues are expected to steadily increase due to the Fischer development with the city realizing the 100% of the property taxes. I campaigned on this and held firm through negotiations since taking office
- Balanced, fiscally responsible budget prepared and adopted in June, 2024.
- Through solid fiscal management, the city will realize a sizable surplus from 2023-2024. This will be used to pay down debt, service existing debts and finance capital intensive expenditures.
- Applied for EV charging station grant and the Fire Safer Grant. The latter could fund up to 3 firefighters/EMTs. The charging station is a pay-as-you-go with a projected break-even for the city in approximately three years. This puts Wilder on the EV grid & increases our traffic, which increases business revenues and in turn, increases the tax revenue to the city.
- Personal meetings with the Wilder businesses have been on-going. I care about their satisfaction with the city, their growth strategy and future development plans. Our businesses generate 72% of our revenues. It's easier to retain a business than to replace one.
- New business opening in the Town Center area Indian Restaurant. Other expansions on the radar.
- Bobby Mackey's facility to be totally remodeled. Expected to begin September, 2024. At completion, his music returns to Wilder.
- New, seven home development across the street from St. John the Baptist Church in the planning stages.
- We remain in contact with the steel plant on the possibility of reopening or redeveloping in the near future.

#### OTHER NOTABLE ACTIVITY AND ACCOMPLISHMENTS FOR THE COMMUNITY AS A WHOLE

- Having proudly served with Councilwoman Decker on the Beautification Committee, and now as Mayor, supported her long-time request for seasonal banners. Taking this a step further, made it a priority in 2024 to replicate the Veteran's banners other cites proudly display to honor our servicemen and women. Thank you to council for the budget, thank you to Sandy for her collaboration and support and big thank you to Terry, Juanita, Karen, Aaron and Andrew for making these beautification initiatives a reality.
- Partnered with the county, Wilder is participating in the Tank-Plus, on-demand, transportation service pilot. Instead of a fixed route, Tank Plus uses smaller vehicles you can schedule on an as needed basis. Insert included in this newsletter.
- Prime piece of city-owned property is for sale. We are accepting proposals. Vacant land sitting idle serves no purpose.
- Wilder Police partnered with other cities to launch the NKY Law Enforcement Peer Support Group.
- Community Gardens made available to residents. Public Works maintained and filled water barrels as needed.
- Bike & walking trails remain a focus area the city continues to work with Duke on a path which would utilize their right away. This is taking more time than anticipated.
- Many recreational events and programs offered. What's to come by year-end: Annual Flag Raising, Senior Picnic, Music
  Fest / Car Cruise-in, Great Pumpkin Hunt, Medicare Informational Seminar, Halloween Night, Turkey Raffle, Snowman
  Scavenger Hunt, Christmas Tree Lighting, Breakfast with Santa, Blood Drive.
- New in 2024 Wilder's participation in and support of the Campbell County Historical & Genealogical Society's Christmas Trees of Honor & Remembrance event. See newsletter insert.
- Outreach Initiatives: announced Coffee and Talk for the residents. On-going, face-to-face business meetings, participating in the Condos HOA meetings, bi-annually when possible and through effective use of Public Service Announcements. With the support of council, the city may be hosting a Town Hall meeting with the objective to garner your input to Wilder's Comprehensive plan which needs to be updated. More information to follow.

#### The City of Wilder, our community and our people, are at the heart of every decision I make as Mayor.

To quote Mark Pope, UK's Men's' Head Basketball Coach, "Slow is smooth and smooth is fast" (\*). This applies to masterful execution. He shared this principle during his speech to government officials and its application to public leadership. It's certainly a principle which can be applied to how we operate as a city: focused, efficient and doing things right the first time.
