# CITY OF WILDER, KENTUCKY ORDINANCE NO. 25-0501

AN ORDINANCE AMENDING CHAPTER 72 SECTION 72.02 OF THE WILDER MUNICIPAL CODE AMENDING STOP SIGN LOCATIONS FOR BENTWOOD HILLS DRIVE A CITY MAINTAINED STREET LOCATED IN THE CITY OF WILDER AND 72.03 PROHIBITED PARKING BY ADDING REGULATIONS CONCERNING UNATTACHED TRAILER, BOATS CAMPERS PARKING ON CITY STREETS.

WHEREAS, the City of Wilder has previously adopted Chapter 72 of the Wilder Municipal Code relating to parking regulations, speed limits and stop sign locations of motor vehicles on city-maintained streets in the City of Wilder; and,

**WHEREAS**, with the extension of Bentwood Hills Drive the city desires to update the stop sign locations on Bentwood Hills Drive, one of the city streets listed in Chapter 72 Section 72.02; and,

**WHEREAS**, the city finds it necessary to make the following amendment to Chapter 72 Section 72.02 of the City of Wilder Municipal Code.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WILDER, CAMPBELL COUNTY, KENTUCKY AS FOLLOWS:

#### **SECTION ONE**

### 72.02 SPEED LIMIT AND PARKING RESTRICTIONS FOR SPECIFIED STREETS.

STREET	SPEED LIMIT	NO PARKING	STOP SIGN LOCATION
Bentwood Hills Drive	20	Both Sides	Intersection with Timberridge Drive and Moock Road and both Intersections with Lakeview Drive

## **SECTION TWO**

#### 72.03 PROHIBITED PARKING

- (G) (1) It is unlawful to park or store upon a public way any device, whether or not attached to a tow vehicle, which is not capable of being driven under its own power (self-propelled) or which cannot legally be operated on public ways.
- (2) Such devices include, but are not limited to boats, boat trailers, flatbed trailers, dumpsters, other tote devices and portable storage containers.
- (3) Any such device parked on the public way is subject to being impounded.
- Excepted are dumpsters and portable storage containers for which written permission has been obtained from the Police Department. Also excepted are devices attached to a tow vehicle when parked for a period of no longer than 24 hours. However, should any such device cause damage to any public way, the owner or permittee shall be responsible for any damage which may be caused thereto and shall, upon invoice for the costs of such repair, reimburse the city for the same.

## **SECTION THREE**

That this Ordinance be read on two separate occasions, shall be signed by the Mayor, attested by the City Clerk/Treasurer published in accordance with law and made a part of the records of the City of Wilder. Same shall be in effect at the earliest time provided by law.
